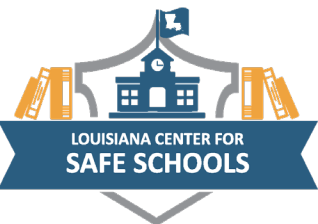

  - Invoiced/Payed: \$1,240,594.65

- GOHSEP/LCSS has notified all FY25 applicants concerning the advanced payment option and the 1 December 2025 project end date.

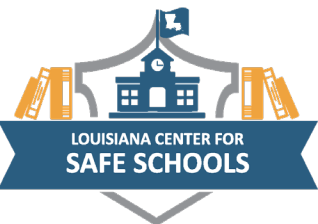

#### E. FY-26 Behavioral Threat Assessment

- **2024 - Behavioral Threat Assessment and Management (BTAM) Training:**
  - Louisiana BTAM Facilitator Manual
  - Louisiana BTAM Practitioner Guide
- **2025 -** The implementation of a statewide standardized integrated Threat Assessment Tool and Central Reporting Mechanism called Outreach, which is a FERPA and HIPAA compliant software platform.

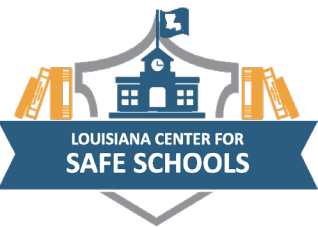
In support of the Louisiana Statewide Threat Assessment and Prevention Plan, Outreach will build on the existing Behavioral Threat Assessment and Management (BTAM) Training to provide infrastructure for multi-agency coordination and communication incorporating the Trauma-Informed Protocol for Threat Assessment.

Outreach will enhance visibility into threat assessment and case management activities at the school, parish, district, regional, and state levels, allowing for more effective and efficient deployment of resources, support, comprehensive training and inter-agency collaboration to prevent violence in our schools.

#### **Initiative Goals and Objectives:**

- Deploy a Statewide integrated Threat Assessment Tool and central reporting mechanism.
- Establish Threat Assessment Procedures, Guidelines, Protocols, and Processes.
- Implement a Statewide Training Program.

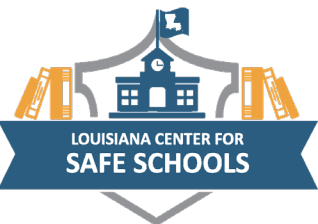
#### F. Bleed Kit Update

##### Kits Issued as of 12/02/2024:

- SWAT-T: 232
- TMT: 23
- Curad: 55
  - Total: 310 Kits
- **1,717 Schools in Louisiana**
  - 1,367 Public and Charter Schools
  - Approximately 350 Private Schools
- **1,219 Schools have been issued Kits**

##### Kits Issued as of 03/19/2025:

- SWAT-T: 904
- TMT: 525
- Curad: 609
  - Total: 2,038 Kits (557.42% Increase)
- **Current Inventory**
  - SWAT-T: 54
  - TMT: 273
  - Curads: 338
  - Total: 665 Kits

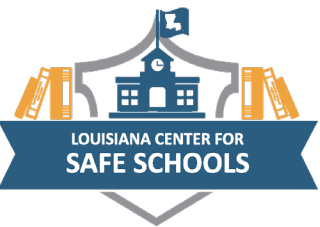

- 713 Schools - Grades 6 and above
- 2024 - 2,327 tips which lead to 6 arrests
- 2025 - 618 tips received from January 1 – March 19
- **February 2025:**
  - Threats of Violence: 7
  - Mental Health/Risk of Self-Harm: 11
  - Bullying: 36
  - Assault: 7
  - Child Abuse, Sexual Misconduct: 9
  - Dating Violence: 2
  - Drugs: 6
  - Gangs: 1
  - Guns: 3
  - Shooting: 2
  - Stealing: 2

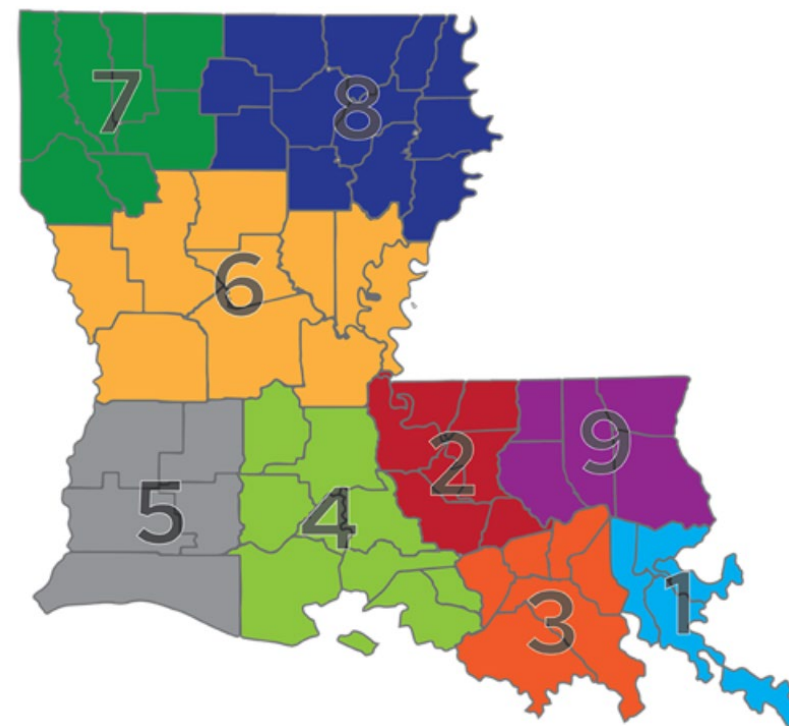

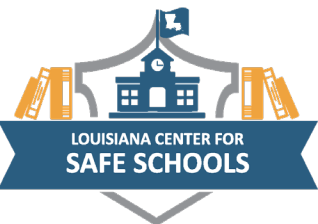

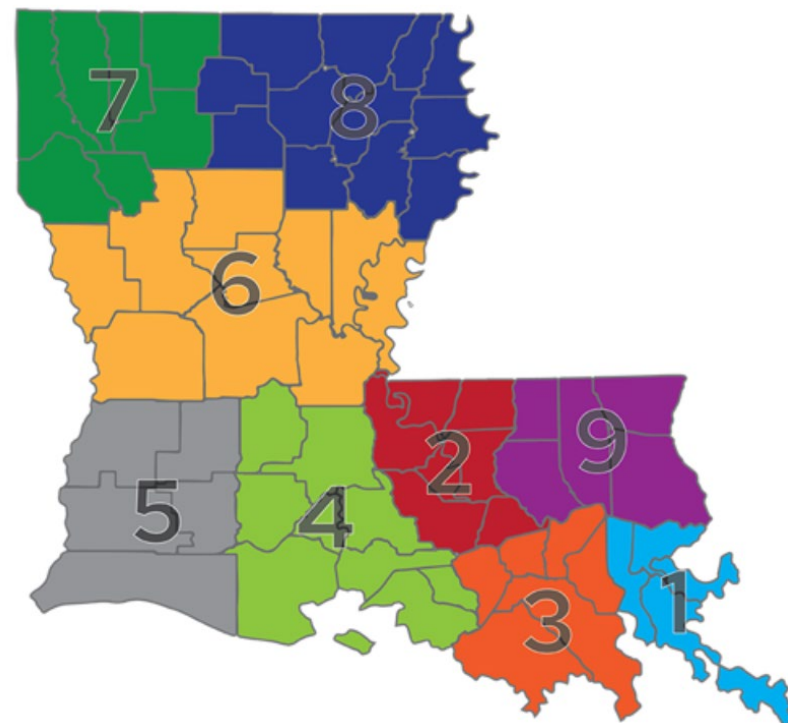

- Provide grant assistance and conduct compliance visits





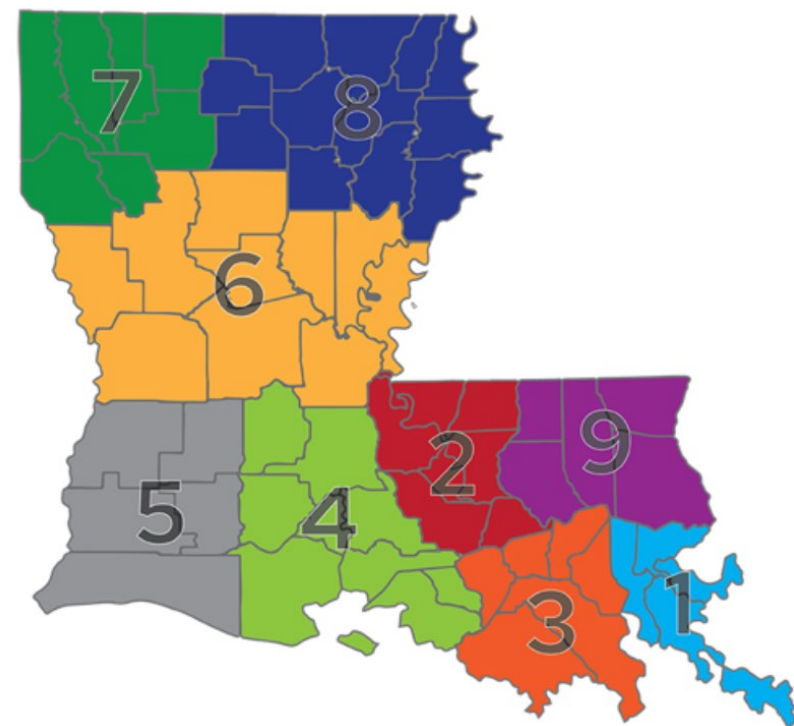

- Develop relationships with all schools/districts





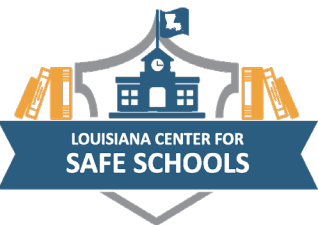

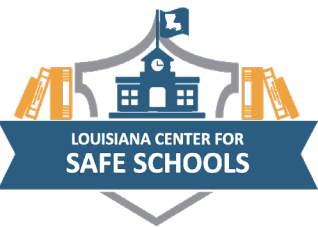

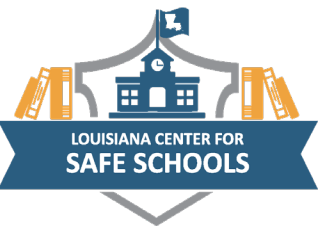
